6	Treasurer's Report	
	The latest Treasurer's report was circulated.	
	The Santon Group have paid their 3-year sponsorship as a lump sum. It was agreed that $\pounds 2,000$ of it will be kept back for use in 2023 and 2024 as required.

	a. Umpires – there was a question as to whether non-associated umpires could be paid. It was agreed that if you want to be paid to umpire you should affiliate to CSMOA	
	b. Nigel now has the lifetime achievement award trophy for Neil Nicol. He hopes to present it at some point in the season	
	c. A Covid guidance update has been issued by Cricket Scotland. Link available from our website. Point to note is that saliva is not to be used on the ball. This will become a law later this year.	
	<ul> <li>d. Teas – it was agreed that clubs could provide water and hot drinks, but no food.</li> </ul>	
	e. CSMOA had sent out an email to all Regional Associations to advise that they were increasing their fees. This had caused general consternation as it was sent without any consultation. It is on the agenda for the next CS meeting where it will be discussed whether CSMOA can dictate fees. It was agreed to stick to our status quo until the policy is clarified.	
	f. It was noted that the MCA and HDG information is out of date on our website. This needs to be updated. Nigel confirmed that clubs were happy for MCA fixtures to be put on the site together with the Cally fixtures from Tony McKenna.	
	g. NoSCA live.com – Chris has completed 2 training sessions. Dates for club training have been sent out and all clubs are strongly advised to attend, and also to try logging on to get to know the system. The results system will be used for the first time this weekend.	
	<ul> <li>h. Playing conditions – item 48 of the 2022 reserve playing conditions has now been updated to reflect a change that was agreed in 2019 i.e. No more than SIX overs will be bowled by any one bowler (i.e., a minimum of five bowlers per innings)"</li> </ul>	
	i. Munro queried playing condition item 70 - it was agreed that it was a bit late in the day to amend playing conditions and it will be revisited for next season.	
	j. There was a discussion as to whether our T20 playing conditions should be amended to bring them in line with the Murgatroyd Cup. It was agreed that it
