4	Cricket Scotland Meeting, Feedback	
	The feedback was generally positive from the meeting with Cricket Scotland representatives. We talked about junior development and coaching. There was a serious apology from CS that things haven't been right. Chris felt that we got our points over. CS will be developing a draft 4 year and 10 year strategy.	
5	Treasurer's Report	
	Forres St Lawrence have received an invoice from Cricket Scotland for subs. Clubs were advised not to pay any invoices they receive direct from CS. Tony will talk to Lucy Preston about this issue.	ТМс
6	Fixtures Round Up and Statistics, Trophies	
	All fixtures are up to date on the results vault. The winners of trophies were confirmed.	
	Clubs will be sent out a nomination form for Player of the Year, Development League Player of the Year, and Junior Player of the Year. Clubs are asked to nominate <b>1 person in each of the categories</b> and that person can be from their own club (there is <b>no obligation to include a name in each category</b> ). There is also an option to nominate an individual for Lifetime Achievement award. If a club wishes to nominate somebody for this award, please include details / reasons for nomination and they will be considered.	NG
7	Player Registration	
	Chris has received communication from some individuals as to how appropriate it was for Forres St Lawrence and Skye to include players from different associations in their teams towards the end of the season. He stressed that the 2 teams have broken no constitutional rules by doing this. It was questioned whether a time limit should be put on the registration of players, however Nicky stated that a number of clubs were registering players right up to the end of the season.	

	Various "caveats" were discussed such as not allowing the transfer to NoSCA if a player has played in a different region.

8	Disciplinary Directive	
	The intention is still for Cricket Scotland to take on Disciplinary cases, but to have a Disciplinary Officer within NoSCA who would be responsible for Level 1 offences and demerit points. If this is the case our constitution would need to be revised and agreed at the AGM.	
	The problem with dealing with any disciplinary cases "in house" is that everybody knows each other, and it is not currently a consistent system.
